COMES NOW, THERESA NANGLE OBERMEYER PH.D., to submit to this court a very small sample of her treatment. It is noted that this is a 45 year old state where there are not established institutions so the issues that she and her husband, Thomas S. Obermeyer, Attorney, have raised relate to many organizations and groups. Obermeyer notes that she and her husband have a web-site: www.tobermeyer.info where some relevant documents have been placed. Additionally, she and her husband have had listings in Todd Communications Alaska Directory of Attorneys for eight years for which they pay more than the attorneys listed. The ad of Obermeyer's husband is on Page 9 and her listings are alphabetically in Alternative Dispute Resolution and under "J" for jurisprudence in the Expert Witness Section. She has tried to pick out the best representation of documents as follows:

This honorable court can get the tapes of State of Alaska/Hilton Anchorage vs. Theresa Nangle Obermeyer 3AN-98-2211 CR regarding her acquittal in Claim No. 98-365 before Violent Crimes Compensation Board. Even though acquitted in a seven day jury trial on November 10, 1998, she continues to receive "Trespass" Notices from Hilton Anchorage yearly which are signed and/or orchestrated by Mr. Jon Dawson, Attorney for Hilton/Anchorage and Partner, Davis, Wright & Tremaine. Mr. Dawson and Mr. Stockler are an embarrassment to this honorable court. Obermeyer believes both would be at least disciplined by any other states' Bar Association along with several other unethical licensed Alaska attorneys. Obermeyer recommends that this honorable court order a transcript printed of 3AN-98-2211 CR in order that this court can review thoroughly how corrupt a handful of attorneys really have been in fabricating endless issues against her and her family but especially her assault at Hilton Anchorage when she had been invited there by the General Manager.

We have attempted since my first lawsuit filed in U.S. District Court, District of Alaska, Anchorage, on October 28, 1981 to resolve our unethical treatment without assistance. I have three “Not for Publication” rulings from U.S. Court of Appeal for the Ninth Circuit

commencing with Theresa Nangle Obermeyer vs. University of Alaska and four rejections from U.S. Supreme Court in Theresa Nangle Obermeyer vs. United States of America. My husband, Thomas S. Obermeyer, Attorney, licensed by similar Missouri Bar Exam in 1990, a state that has reciprocity with Alaska, is still not licensed to practice law in Alaska even though he has paid for, studied for, and taken 28 Alaska Bar Exams for 84 days of his life. Tom has appealed and has two rejections from U.S. Supreme Court in Thomas S. Obermeyer, Attorney, vs. Alaska Bar Association. There is absolutely no accountability of Alaska Bench and Bar. I have the court filings and signatures of Mr. Bob Ely and Mr. Mitchell Gravo who are both convicted criminals. Neither has been disciplined by Alaska Bar Association, 550 West 7th, Suite 1900, Anchorage (907)272-7469, (907)272-2932 Fax www.alaskabar.org.

The incumbent Anchorage School Board members are Mr. Jake Metcalfe, Attorney, President, Anchorage School Board, metcalfe_jake@asdk12.org, and Mr. Tim Steele, V-P, Anchorage School Board, steele_tim@asdk12.org have continued since January 19, 2000 my "Trespass" at East High School, where our children go to school, in an effort to tear our family apart. I have not met our children's teachers in over four years. Little did Jermain, Dunnagan & Owens realize that my husband is even more vigilant than I in making absolutely certain our children are doing well. Thanks and gratitude go to the teachers and staff at East High who have helped our children every day.

On Saturday, March 13, 2004 South Central Region Precinct/District Caucuses will be held at East High School. I will be denied freedom of assembly and freedom of speech because of these corrupt Alaska "lawyers" and "educators." Unless I get a letter that I am welcome at our children's high school, I will be unable to go to the Caucuses this Saturday. This will be the first time in my adult life that I have not participated in this very important part of the partisan election process.

Additionally, this very unethical group of attorneys and educators have set up the Alaska State Convention on May 21-23, 2004 at Hilton Anchorage. Please review www.tobermeyer.info file "Acquittal Trial by Jury: State of Alaska/Hilton Anchorage vs. Theresa Nangle Obermeyer 3AN-S98-2211 CR" Mr. Jon Dawson, Attorney Partner, Davis, Wright & Tremaine, a third generation Alaskan, wrote me a letter on February 8, 1999 that I was still a "trespasser" at Hilton Anchorage even though I had been acquitted in a seven day jury trial. My civil lawsuit for vindictive prosecution is still ripe today because every year I get a letter from Hilton Anchorage that I am still a trespasser there. I got a letter to that effect from Mr. C. Kevin Batters, current General Manager, Hilton Anchorage, www.hilton.com (800)HILTONS dated February 2, 2004. Hilton International is the largest gambling organization in the world. Really two lawyers are responsible for my denial of freedom of assembly and freedom of speech; Mr. Howard Trickey, Partner, Jermain, Dunnagan & Owens, and Mr. Jon Dawson, Partner, Davis, Wright & Tremaine. Anywhere else in United States of America these unbelievably unethical licensed Alaska attorneys would be disbarred. I filed my first 100 page complaint with Mr. Stephen Van Goor, Bar Counsel, Alaska Bar Association, against Mr. Trickey, and have filed 32 other complaints about unethical and criminal acts by licensed Alaska attorneys throughout 1990s including Mr. Dawson.
