I was acquitted after a seven day jury trial on November 10, 1998 while I had a pending Violent Crimes Compensation Board (VCCB) Claim No.98-365 on the same issues filed 2/28/98. VCCB hired Mr. Paul Stockler, Attorney, who held the hearing 1/26/99 even though I had been acquitted and ruled against me. Dr. Colleen Murphy and Ms. Leslie Wheeler, VCCB, agreed to my conviction per "award order forms" received October 18, 1999. I continue every year to get Trespass Notices from Mr. Jon Dawson, Partner, Davis, Wright & Tremaine, and Attorney for Hilton Anchorage most recently on February 2, 2005.

Subject: Pending Complaint Against Dr. Colleen Murphy, Alaska State Medical Association

Dear Dr. Fraser and ASMA Grievance Committee:

Please let me know if Grievance Committee, Alaska State Medical Association, intends to rule on my pending complaint against Dr. Murphy. As I have mentioned in the past, my situation is different from others in that it is based on belief in trial by jury. Dr. Murphy signed her name twice as a designated Medical Doctor on Violent Crime Compensation Board (VCCB) that she does not believe in trial by jury regarding VCCB Complaint 98-365. For your information, I believe that Dr. Murphy's first signature on "AWARD ORDER FORM" dated October 5, 1998 was backdated because I was not given both forms including that one and the other one dated September 20, 1999 until October 18, 1999. Please review the term forgery in Black's Law Dictionary which means "a person is guilty of forgery if, with purpose to defraud or injure anyone, or with knowledge that he is facilitating a fraud or injury to be perpetrated by anyone, the actor: . . . authenticates. . . execut(ion) at a time. . . other than was in fact the case. . ." As I have explained, I was acquitted in a jury trials on November 10, 1998 while my complaint with VCCB was pending so I simply wrote to ask for the Board's acknowledgement that I had been acquitted which Dr. Murphy denied with her two signatures that I received October 18, 1999. I consider her actions as a highly educated designated Medical Doctor on VCCB very unethical.
